Health Notice #68

January 3, 2022

Between December 31st and January 3rd, Mt. Blue Regional School District was notified that **32 (thirty-two)** people associated with our district have tested positive for COVID-19. Contact tracing has been completed and **24 (twenty-four)** close contacts were identified and have been notified. Of these close contacts, **1 (one)** is required to quarantine and **23 (twenty-three)** are allowed to attend school due to their meeting one of Maine CDC's exemptions: participate in universal masking, participate in pooled testing, are fully vaccinated, or were COVID-19 positive in the past 90 days.

Please be assured that our efforts to keep our schools safe continue and that our buildings are cleaned in accordance with all Maine CDC guidelines. *Please complete this [form](#) if you have any questions and would like an RSU 9 staff member to reach out to you.* The number of cases and the impacted schools/locations are included below.
